The purpose of this filing is to update the Culver City system tariff map in the Region 2 customer service area to bring into conformance with the actual territory served by GSWC.

**Request**

GSWC is requesting to update its current Culver City System tariff map on file with the California Public Utilities Commission's Water Division to reflect the actual area served. The revised map updates an area within GSWC's service territory that was not shown in the last update. The layout of the map has been updated to show an addresses along Mesmer Avenue that is outside the current service area boundaries. GSWC has served this address since 1977.

The filing of this map will not increase any rate or charge, cause the withdrawal of service nor conflict with other schedules or rules.

**Tier Designation**

This advice letter is submitted with a Tier 1 designation. GSWC requests that this filing be effective 30 days after the filing, which is September 4, 2020.

**Response or Protest**

Anyone may submit a response or protest for this AL. When submitting a response or protest, **please include the utility name and advice letter number in the subject line.**

A **response** supports the filing and may contain information that proves useful to the Commission in evaluating the Advice Letter (AL). A **protest** objects to the AL in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

1. The utility did not properly serve or give notice of the AL;
2. The relief requested in the AL would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
3. The analysis, calculations, or data in the AL contain material error or omissions;
4. The relief requested in the AL is pending before the Commission in a formal proceeding; or
5. The relief requested in the AL requires consideration in a formal hearing, or is otherwise inappropriate for the AL process; or
6. The relief requested in the AL is unjust, unreasonable, or discriminatory, provided that such a protest may not be made where it would require re-litigating a prior order of the Commission.

A protest may not rely on policy objections to an AL where the relief requested in the AL follows rules or directions established by statute or Commission order applicable to the utility. A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

DWA must receive a response or protest via email (or postal mail) within 20 days of the date the AL is filed. When submitting a response or protest, **please include the utility name and advice letter number in the subject line.**

be entertained. The informing document should include an estimate of the date the proposed protest might be voted on.

**Replies**

The utility shall reply to each protest and may reply to any response. Any reply must be received by DWA within five business days after the end of the protest period, and shall be served on the same day on each person who filed the protest or response to the AL.



The actions requested in this advice letter are not now the subject of any formal filings with the California Public Utilities Commission, including a formal complaint, nor action in any court of law.
