The purpose of this filing is to update the Region 2 Artesia System tariff map to bring it into conformance with the actual territory served by GSWC.

Request

GSWC is requesting to update its current Artesia system tariff map on file with the California Public Utilities Commission's Water Division to reflect the actual area served. The revised map updates an area within GSWC's Central Basin East customer service area that was not shown in the last update. The Artesia system map has been updated to show the entire area served by GSWC, including the parcel of land on Clarkdale Avenue, in the city of Cerritos. GSWC has served this parcel since 1962.

The filing of this map will not increase any rate or charge, cause the withdrawal of service nor conflict with other schedules or rules.

Tier Designation

This advice letter is submitted with a Tier 1 designation. GSWC is requesting that this filing become effective on February 25, 2022.

Response or Protest

Advice Letter 1871-W

A **response** supports the filing and may contain information that proves useful to the Commission in evaluating the Advice Letter (AL). A **protest** objects to the AL in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

- 1. The utility did not properly serve or give notice of the AL;
- 2. The relief requested in the AL would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- 3. The analysis, calculations, or data in the AL contain material error or omissions;
- 4. The relief requested in the AL is pending before the Commission in a formal proceeding; or
- 5. The relief requested in the AL requires consideration in a formal hearing, or is otherwise inappropriate for the AL process; or
- 6. The relief requested in the AL is unjust, unreasonable, or discriminatory, provided that such a protest may not be made where it would require re-litigating a prior order of the Commission.

A protest may not rely on policy objections to an AL where the relief requested in the AL follows rules or directions established by statute or Commission order applicable to the utility. A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

WD must receive a response or protest via email (<u>or</u> postal mail) within 20 days of the date the AL is filed. When submitting a response or protest, **please include the utility name and advice letter number in the subject line.**


