# Subject: 2023 Escalation Year -Arden Cordova

### **PURPOSE**

This advice letter advises the Water Division that GSWC does not qualify for and will not be seeking an Escalation Year 2023 increase for its Arden Cordova CSA.

GSWC's notification to the Water Division is being made pursuant to Decision No. 23-06-024, dated June 29, 2023, its General Rate Case Application (Application No. 20-07-012). Specifically, Ordering Paragraph No. 1 of Decision No. 23-06-024 states,

1. The Joint Motion of Golden State Water Company and the Public Advocates Office for the Adoption of a Settlement Agreement, filed November 23, 2021, is granted; and the Settlement Agreement attached to this decision as Appendix A is approved and adopted.

# Ordering Paragraph No. 6 states,

6. For escalation years 2023 and 2024, Golden State Water Company (GSW) must file Tier 1 advice letters in conformance with General Order 96-B proposing new revenue requirements and corresponding revised tariff schedules for each ratemaking area in this proceeding. The advice letters must follow the escalation procedures set forth in the Revised Rate Case Plan for Class A Water Utilities adopted in Decision 07-05-062 and must include supporting workpapers. GSW must file for rate reduction if the escalation procedures result in a rate reduction due to negative rate base growth, inflation factors, or customer growth. The revised tariffs shall be effective as of January 1, 2023, and January 1, 2024, respectively and apply to services rendered on and after their effective dates. The proposed revised revenue requirements and rates must be reviewed by the Commission's Water Division. The Water Division must inform the Commission if it finds that the revised rates do not conform to the Revised Rate Case Plan, this decision, or other Commission decisions, and if so, reject the filing.

## **RATE OF RETURN**

The following summary lists the Recorded, Authorized, Adjusted Authorized and Proforma rates of return in the Arden Cordova CSA for twelve months ending September 2022. The pro forma rate of return is calculated in accordance with the escalation procedures set forth in the Revised Rate Case Plan for Class A Water Utilities adopted in Decision 07-05-062.

Recorded	5.74%
Authorized	<b>7.91</b> %
Adjusted Authorized	8.68%
Pro forma	10.09%

As shown above, the Pro forma rate of return for the 12 months ending September 2022 exceeds GSWC's Adopted rate of return, therefore, based on the escalation calculation procedures, Arden Cordova does not qualify for an Escalation increase in 2023. Therefore, GSWC will only be implementing the rate increase approved for Year 2022.

Detailed supporting workpapers are being supplied to the Commission Staff.

# REQUEST TO CLOSE SCHEDULE NO. AC-1 AND AC-2

GSWC is requesting to close Schedule No. AC-1 General Metered Service and Schedule No. AC-2, Flat Rate Service from its Tariff book. The customers served under these rate schedules will now be served under the respective Schedule No. AC-1-R, Residential Metered Service and Schedule No. AC-1-NR, Non-Residential Metered Service as approved in Decision No. 23-06-024.

# **REQUEST TO CLOSE SCHEDULE AC-3**

In compliance with Resolution No. W-5237, GSWC is transitioning all customers in the Robbins Water System to Schedule No. AC-1-R, Residential Meter Service. GSWC is closing Schedule No. AC-3 and is removing it from its tariff book.

# TEMPORARY SURCHARGES AND SURCREDITS

In compliance with D.23-06-024, GSWC will be implementing the temporary surcharges and surcredits as shown in Appendix I in the Settlement Agreement on the effective date of the 2023 Escalation rates.

# TIER DESIGNATION

This advice letter is submitted with a Tier 1 designation.

# EFFECTIVE DATE

As directed, the effective date of these revised tariffs shall be July 31, 2023.

# **CUSTOMER NOTICE**

This is a Tier 1 advice letter that does not require customer notification, as provided in Water Industry Rule 7.3.1 of General Order 96-B. GSWC will include a bill message on the customer's bill after the increase goes into effect to inform its Arden Cordova customers of this rate increase.

# **RESPONSE OR PROTEST**

Anyone may submit a response or protest for this Advice Letter (AL). When submitting a response or protest, **please include the utility name and advice letter number in the subject line.** 

A **response** supports the filing and may contain information that proves useful to the Commission in evaluating the AL. A **protest** objects to the AL in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

- 1. The utility did not properly serve or give notice of the AL;
- 2. The relief requested in the AL would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- 3. The analysis, calculations, or data in the AL contain material error or omissions;
- 4. The relief requested in the AL is pending before the Commission in a formal proceeding; or

- 5. The relief requested in the AL requires consideration in a formal hearing, or is otherwise inappropriate for the AL process; or
- 6. The relief requested in the AL is unjust, unreasonable, or discriminatory, provided that such a protest may not be made where it would require re-litigating a prior order of the Commission.

A protest may not rely on policy objections to an AL where the relief requested in the AL follows rules or directions established by statute or Commission order applicable to the utility. A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

WD must receive a response or protest via email (<u>or</u> postal mail) within 20 days of the date the AL is filed. When submitting a response or protest, **please include the utility name and advice letter number in the subject line.** The addresses for submitting a response or protest is:

The informing document should include an estimate of the date the proposed protest might be voted on.

# **REPLIES**

The utility shall reply to each protest and may reply to any response. Any reply must be received by WD within five business days after the end of the protest period, and shall be served on the same day on each person who filed the protest or response to the AL.

The actions requested in this advice letter are not now the subject of any formal filings with the California Public Utilities Commission, including a formal complaint, nor action in any court of law.
