PURPOSE

The purpose of this filing is to update GSWC's Apple Valley-South tariff area map in the Region 3 service territory to provide domestic and irrigation water service to a proposed commercial water customer. This new service is within GSWC's existing Apple Valley-South service area. Fire protection service to the location will be provided by Liberty Utilities ("Liberty"), an adjacent water utility. Liberty is also regulated by the California Public Utilities Commission ("CPUC" or "Commission").

BACKGROUND

The owner of Apple Valley Pro Storage submitted an Application for Water Service to GSWC to provide domestic and irrigation water service to 20471 Bear Valley Road, Apple Valley, CA. This location will be used for a public self-storage building. The proposed area is within GSWC's existing, approved service area boundaries.

The developer is proposing to construct a new public storage building and the San Bernardino County Fire Department ("SBCFD") is requiring a range between 2,500 - 3,500 gpm fire flow as a condition of permitting the new building. At this time, GSWC is unable to provide the SBCFD's recommended fire flow. GSWC and Liberty have agreed that Liberty has the ability to provide fire protection at the required fire flow. Liberty will be filing a similar advice letter to identify that they are providing fire protection service to this location, with a tariff map update.

REQUEST

GSWC is requesting to update its current Apple Valley-South tariff area map on file with the Commission's Water Division to reflect the arrangement with Liberty to provide fire flow service to the storage building. Since this location is already within GSWC's service territory, GSWC will be providing the domestic and irrigation water service.

Liberty will be filing an advice letter to add the same property to their current tariff area map. This property will be shown on both GSWC and Liberty tariff area maps and depicted with a distinct pattern for the purpose of identifying the property as receiving split services.

GSWC's Apple Valley-South tariff area map was last updated in Advice Letter No. 1758-W, effective December 9, 2018.

GSWC's Apple Valley-South tariff area map is Geographical Information System compliant, according to the specifics in General Order 96-B, General Rules, Section 8.5.4.

The filing of this map will not increase any rate or charge, cause the withdrawal of service nor conflict with other schedules or rules.

TIER DESIGNATION

This advice letter is submitted with a Tier 2 designation. GSWC is requesting that this filing become effective on January 4, 2025.

Pursuant to Water Industry Rule No. 3.2 in the Commission's General Order 96-B, this advice letter does not require a customer notice nor a customer notice verification.

RESPONSE OR PROTEST

Anyone may submit a response or protest for this Advice Letter ("AL"). When submitting a response or protest, **please include the utility name and advice letter number in the subject line.**

A **response** supports the filing and may contain information that proves useful to the Commission in evaluating the AL. A **protest** objects to the AL in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

1. The utility did not properly serve or give notice of the AL;
2. The relief requested in the AL would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
3. The analysis, calculations, or data in the AL contain material error or omissions;
4. The relief requested in the AL is pending before the Commission in a formal proceeding; or

5. The relief requested in the AL requires consideration in a formal hearing, or is otherwise inappropriate for the AL process; or
6. The relief requested in the AL is unjust, unreasonable, or discriminatory, provided that such a protest may not be made where it would require re-litigating a prior order of the Commission.

A protest may not rely on policy objections to an AL where the relief requested in the AL follows rules or directions established by statute or Commission order applicable to the utility. A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

Cities and counties that need Board of Supervisors or Board of Commissioners approval to protest should inform the Water Division, within the 20-day protest period, so that a late filed protest can be entertained. The informing document should include an estimate of the date the proposed protest might be voted on.

Replies

The utility shall reply to each protest and may reply to any response. Any reply must be received by the Water Division within five business days after the end of the protest period, and shall be served on the same day on each person who filed the protest or response to the AL.

The actions requested in this advice letter are not now the subject of any formal filings with the California Public Utilities Commission, including a formal complaint, nor action in any court of law.

No individuals or utilities have requested notification of filing of tariffs. Distribution of this advice letter is being made to the attached service list in accordance with General Order No. 96-B.

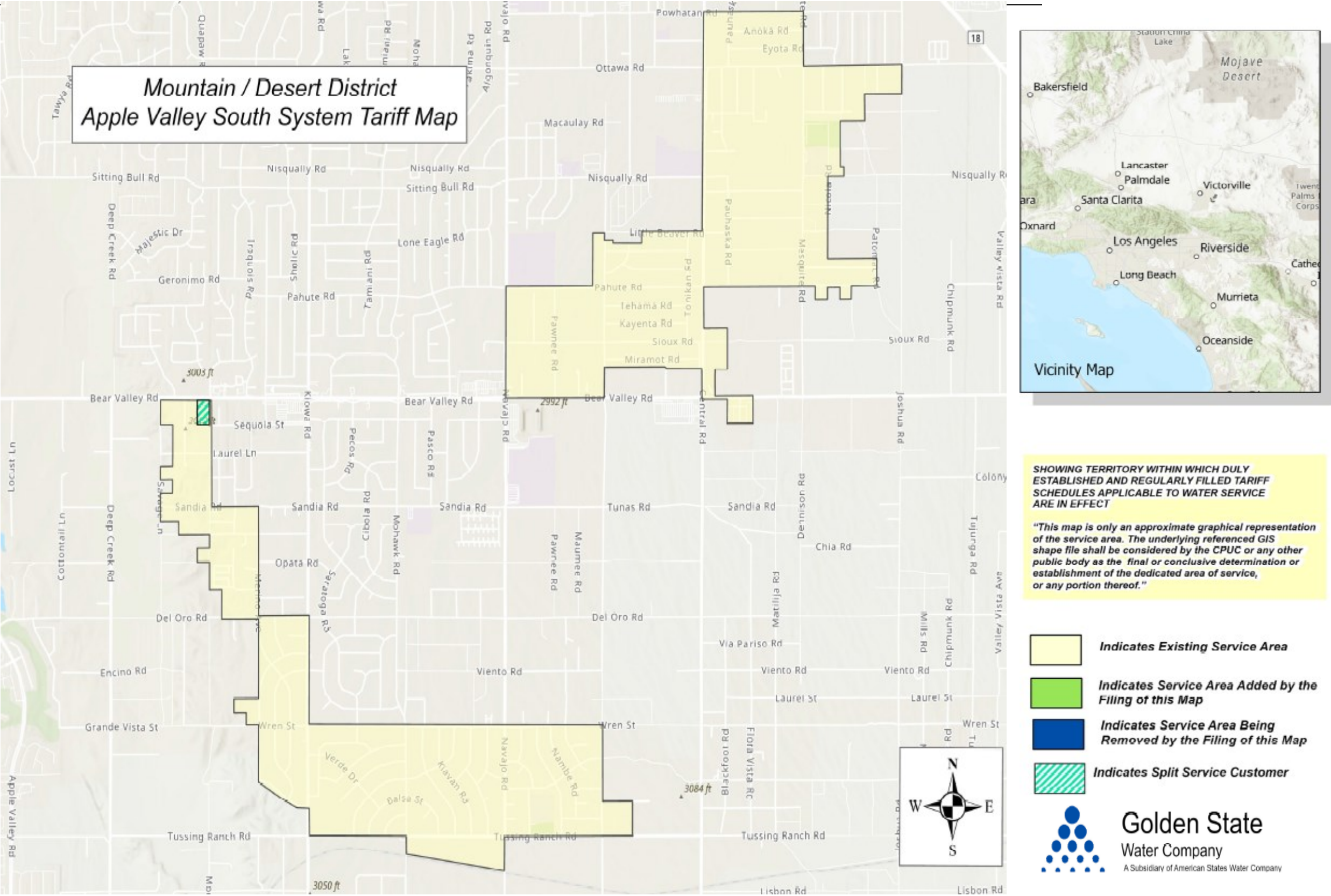
