Golden State Water Company (GSWC) hereby transmits this Tier 1 advice letter requesting the following changes to tariff sheets applicable to its Santa Maria Customer Service Area (CSA):

<u>Request</u>

GSWC is requesting to update its current Santa Maria Orcutt system map on file with the California Public Utilities Commission's Water Division to reflect the actual areas served.

The revised Orcutt system map update includes parcels that were not in alignment with the boundaries of the service area in the previous map filing. The map was last updated in February 2021.

The layout of the map has been updated to remove the parcels along Foster Road, which are served by Foster Road Mutual Water Company. GSWC has not served these parcels historically.

Additionally, the update of the map is removing an area on the north part of the service area that is not served by GSWC.

The filing of this map will not increase any rate or charge, cause the withdrawal of service nor conflict with other schedules or rules.

Tier Designation

This advice letter is submitted with a Tier 1 designation. GSWC is requesting that this filing become effective on October 31, 2025.

Response or Protest

Anyone may respond to or protest this advice letter (AL). When submitting a response or protest, please include the utility name and advice letter number in the subject line. A response supports the filing and may contain information that proves useful to the Commission in evaluating the advice letter. A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

- 1. The utility did not properly serve or give notice of the AL;
- 2. The relief requested in the AL would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- 3. The analysis, calculations, or data in the AL contain material error or omissions;
- 4. The relief requested in the AL is pending before the Commission in a formal proceeding; or
- 5. The relief requested in the AL requires consideration in a formal hearing, or is otherwise inappropriate for the AL process; or
- 6. The relief requested in the AL is unjust, unreasonable, or discriminatory, provided that such a protest may not be made where it would require re-litigating a prior order of the Commission.

A protest may not rely on policy objections to an AL where the relief requested in the AL follows rules or directions established by statute or Commission order applicable to the utility. A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

A response or protest must be made in writing or by electronic mail and must be received by the Water Division (WD) within 20 days of the date this advice letter is filed. The address for mailing or delivering a protest is:

Cities and counties that need Board of Supervisors or Board of Commissioners approval to protest should inform WD, within the 20 day protest period, so that a late filed protest can be entertained. The informing document should include an estimate of the date the proposed protest might be voted on.

Replies



Any reply must be received by WD within five business days after the end of the protest period, and shall be served on the same day on each person who filed the protest or response to the AL. The actions requested in this advice letter are not now the subject of any formal filings with the California Public Utilities Commission, including a formal complaint, nor action in any court of law.

No individuals or utilities have requested notification of filing of tariffs. Distribution of this advice letter is being made to the attached service list in accordance with General Order No. 96-B.




