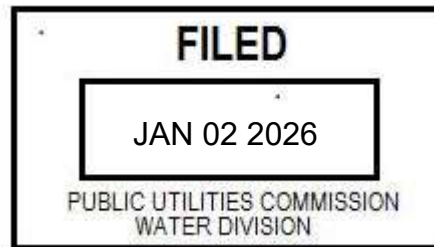

## **TO THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA**

Golden State Water Company (GSWC) hereby transmits this advice letter to inform the California Public Utilities Commission (Commission) of its third payment transfer of PFAS Contamination Settlement Funds from GSWC to Orange County Water District (OCWD), as authorized in the approval of Advice Letter (AL) 1969-WA.

### **Background**

The Commission approved GSWC's AL 1969-WA, effective September 30, 2025. This approval authorized GSWC to transfer certain litigation settlement funds to OCWD for PFAS treatment facilities designed, constructed and funded by OCWD, at GSWC groundwater production plant sites within the Orange County Basin (OC Basin). AL 1969-WA authorized the transfer of approximately \$1.1M in PFAS Contamination Settlement Funds to OCWD from the first of several settlement funds expected from defendants of a Multidistrict Litigation (MDL) over PFAS contamination in drinking water sources. AL 1969-WA authorized future settlement payments to OCWD through the filing of a Tier 1 AL, as additional settlement payments are received by GSWC and transferred to OCWD.

In December 2025, GSWC received its third settlement payment from one of the major defendants of the MDL. This payment included approximately \$631,000 in settlement funds for GSWC groundwater wells within the OC Basin contaminated by PFAS compounds.

### **Compliance**

In compliance with AL 1969-WA, GSWC hereby notifies the Commission that it will make the third settlement payment in accordance with the agreements executed with OCWD for funding of PFAS Treatment Facilities.

This advice letter will not increase any rate or charge, cause the withdrawal of service, or conflict with any other schedule, or rule.

**TO THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA**

Golden State Water Company (GSWC) hereby transmits this advice letter to inform the California Public Utilities Commission (Commission) of its third payment transfer of PFAS Contamination Settlement Funds from GSWC to Orange County Water District (OCWD), as authorized in the approval of Advice Letter (AL) 1969-WA.

**Background**

The Commission approved GSWC's AL 1969-WA, effective September 30, 2025. This approval authorized GSWC to transfer certain litigation settlement funds to OCWD for PFAS treatment facilities designed, constructed and funded by OCWD, at GSWC groundwater production plant sites within the Orange County Basin (OC Basin). AL 1969-WA authorized the transfer of approximately \$1.1M in PFAS Contamination Settlement Funds to OCWD from the first of several settlement funds expected from defendants of a Multidistrict Litigation (MDL) over PFAS contamination in drinking water sources. AL 1969-WA authorized future settlement payments to OCWD through the filing of a Tier 1 AL, as additional settlement payments are received by GSWC and transferred to OCWD.

In December 2025, GSWC received its third settlement payment from one of the major defendants of the MDL. This payment included approximately \$631,000 in settlement funds for GSWC groundwater wells within the OC Basin contaminated by PFAS compounds.

**Compliance**

In compliance with AL 1969-WA, GSWC hereby notifies the Commission that it will make the third settlement payment in accordance with the agreements executed with OCWD for funding of PFAS Treatment Facilities.

**Customer Notice**

Pursuant to Water Industry Rule No. 3.2 in the Commission's General Order 96-B, this advice letter does not require customer notice.

**Response or Protest**

Anyone may respond to or protest this advice letter (AL). When submitting a response or protest, please include the utility name and advice letter number in the subject line. A response supports the filing and may contain information that proves useful to the Commission in evaluating the advice letter. A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

1. The utility did not properly serve or give notice of the AL;
2. The relief requested in the AL would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
3. The analysis, calculations, or data in the AL contain material error or omissions;
4. The relief requested in the AL is pending before the Commission in a formal proceeding; or
5. The relief requested in the AL requires consideration in a formal hearing, or is otherwise inappropriate for the AL process; or
6. The relief requested in the AL is unjust, unreasonable, or discriminatory, provided that such a protest may not be made where it would require re-litigating a prior order of the Commission.

A protest may not rely on policy objections to an AL where the relief requested in the AL follows rules or directions established by statute or Commission order applicable to the utility. A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

A response or protest must be made in writing or by electronic mail and must be received by the Water Division (WD) within 20 days of the date this advice letter is filed. The address for mailing or delivering a protest is:

Cities and counties that need Board of Supervisors or Board of Commissioners approval to protest should inform WD, within the 20-day protest period, so that a late filed protest can be entertained. The informing document should include an estimate of the date the proposed protest might be voted on.

**Replies**

The utility shall reply to each protest and may reply to any response. Any reply must be received by WD within five business days after the end of the protest period, and shall be served on the same day on each person who filed the protest or response to the AL.

The actions requested in this advice letter are not now the subject of any formal filings with the California Public Utilities Commission, including a formal complaint, nor action in any court of law.

No individuals or utilities have requested notification of filing of tariffs. Distribution of this advice letter is being made to the attached service list in accordance with General Order No. 96-B.
