


Introduction



California Water Association Meet the Primes CWA R.I.S.E. Accelerator

A critical part of Golden State Water Company's Supplier Diversity Program is the management of its relationship with our prime contractor partners. The California Water Association Meet the Primes event is key to our plan to introduce subcontractors to our prime contractors. Subcontractors and prime contractors have access to upcoming opportunities. 


External Program Activities
