

Golden State Water Begins \$4.7 Million Pipe Replacement Project in the Hawthorne and Inglewood

Golden State Water Company (Golden State Water) would like to thank our Hawthorne and Inglewood customers for their patience as crews work to complete a \$4.7 million pipeline replacement project in your community.

Project Overview: The project includes the installation of more than 3.3 miles (17,600 LF) of new PVC pipe, water services and fire hydrants to improve the distribution system and ensure Golden State Water can continue providing reliable water service to local customers.

Timeline: June 19, 2018 – March 8, 2019

Location: New pipeline will be installed on Atkinson Ave., Chanera Ave., Ardath Ave. and Wilkie Ave.

Project Details:

- The project will generally take place from Monday to Friday, excluding holidays, between the working hours of 8:30 a.m.-3:30 p.m. (8:30 a.m.-2:30 p.m. near schools) in the City of Hawthorne, and between the working hours of 8:30 a.m.-4 p.m. in the City of Inglewood.
- While the project is underway, local residents may notice sections of roadway that appear unfinished. Once completed, Golden State Water will restore the road, placing permanent asphalt over the excavated areas. Final paving is estimated to commence at the beginning of February and be completed within four weeks.
- Streets will remain open to traffic during the construction period, but minor delays should be expected during certain construction tasks, such as installing the main pipelines, services, and paving. Traffic and parking may be restricted and access to driveways may be temporarily limited for short durations of time. Traffic control will be implemented during the normal working hours.
- Please expect an increased level of noise and traffic during the construction period.
