SPECIAL CONDITIONS

1. All bills are subject to the reimbursement fee set forth on Schedule No. UF.
2. Residential customers are defined as all single family customers with one dwelling unit that are individually metered.
3. Pursuant to Decision 19-05-044, a surcharge of \$0.173 per Ccf will be applied to all metered customers bills excluding customers that are receiving the CARW credit. This surcharge will offset the CARW credits and CARW administrative program costs recorded in the CARW Balancing Account. (D)
5. As authorized by the California Public Utilities, an amount of \$0.555 per Ccf based on an 18-month amortization period, is to be added to the Quantity Rate, beginning on February 19, 2020 as indicated in Advice Letter 1809-W. The surcharge may be recalibrated annually, if necessary. This surcharge will recover the under-collection in the WRAM&MCBA Balancing Account. (D)
6. Beginning August 16, 2019, as required by Section 792.5 of the Public Utilities Code, an increase in purchased power of \$0.01088/kWh, an increase in Purchased Water of \$0.18683/ Ccf and an increase in Pump Tax of \$.03841/Ccf, relative to the Purchased Power, Purchased Water and Pump Tax cost adopted by Decision No. 19-05-044, and an associated revenue increase of 1.62%, are being tracked in a reserve account. (L)
