### **Residential Rebates**

#### **Flume Water Flow Monitoring Device Rebate**

GSWC partners with the California Water Efficiency Partnership (CalWEP) to provide a special offer for the Flume device that attaches to your water meter and provides single-family customers almost real time data on their water use and detect leaks. You will need reliable Wi-Fi at the installation location, and a smart device such as a smartphone or tablet with app-accessibility to access information from the device. The net cost to customers may be as low as \$25 plus shipping and tax, after rebate and refund. ### **Rachio Weather-Based Irrigation Controller Rebate**

GSWC partners with the California Water Efficiency Partnership (CalWEP) to provide a special offer for the Rachio weather-based irrigation smart controller. The offer is for a discounted Rachio Smart Sprinkler Controller for eligible GSWC residents. The Rachio R3 8 zone is only \$69.99+tax and the 16 zone is \$89.99+tax (up to a \$249+ value). ### **Premium High Efficiency Toilet (PHET) Rebate**

- Up to \$80.00 each limited to the cost of the toilet (installation not included).
- New toilet must flush 1.06 gallons per flush or less.
- Must be replacing a toilet flushing 1.6 gallons per flush or more.
- New toilet must be on the approved EPA WaterSense list found [HERE](#).
- Limit 2 per household.

### **High Efficiency Clothes Washer (HECW) Rebate**

- Up to \$80.00 for qualifying models on the list found [HERE](#).

### **Weather-Based Irrigation Controllers (Smart Controllers) Rebate**

- Up to \$100 for approved models found [HERE](#).
- Rebate up to the purchase price not including shipping and tax.

### **Soil Moisture Sensor**

- Up to \$100 for approved models found [HERE](#).
- Rebate up to the purchase price not including shipping and tax.


### **Rotating Sprinkler Nozzle Rebate**

- Up to \$4 per nozzle with a minimum purchase of 15.
- Approved model list found [HERE](#).

### **Flow Monitor Device**

Flow Monitor devices monitor your home's water use and can help detect leaks. Some models attach to the meter; others are installed in-line after the meter and may require professional installation. You will need reliable Wi-Fi at the installation location, and a smart device such as a smartphone or tablet with app-accessibility to access information from the device.

- \$100 rebate for approved models.

### **Drip Irrigation Rebate**

- \$0.25 rebate per linear foot of ½" drip tubing.
  - ¼" drip tubing is NOT eligible.
  - Drip tubing can have emitters in-line or use micro tubing, drip emitters, dripline, and micro sprinklers attached as part of the drip irrigation system.
  - The irrigation system can attach to a hose bib or irrigation valves.
- Irrigation products attached to the ½" tubing are not eligible for rebate.
- Provided receipts must clearly indicate the tubing product and size.

### **Rain Barrel Rebate**

- Receive \$35 per rain barrel purchased and installed.
- Maximum of 3 barrels with a minimum of 50 gallons each.
- Must submit pictures of installed rain barrels with rebate application.

## Commercial, Institutional, Industrial and Large Landscape Rebates

### Premium High Efficiency Toilets (gravity tank types)

- Up to \$80 for qualifying tank type models found [HERE](#).
- Qualifying flush valve models found [HERE](#).
- Replacing valves only does not qualify. Must replace toilet and valve.

### High-Efficiency Flush-Valve Toilets

- \$200 for qualifying flush valve toilets.
- Qualifying flush valve models found [HERE](#).
- Replacing valves only does not qualify. Must replace toilet and valve.

### High Efficiency Urinals (low and zero water use)

- Up to \$200 for qualifying models found [HERE](#).

### Weather-Based (Smart) Irrigation Controllers

- Up to \$100 for sites less than 1 acre.
- Up to \$35 per valve for sites more than one acre.
- Approved model list [HERE](#).

### Efficient Nozzles and Rotors

- Up to \$4 per nozzle with a minimum purchase of 15.
- Up to \$13 per rotor pair with a minimum purchase of 8 pair.

## W-9 TAX FORM REQUIREMENT

---

Federal IRS tax law requires water rebate program participants that receive \$600 or more in rebates in a calendar year to report that gain on their tax form. GSWC may issue a 1099 form on any rebate(s) totaling \$600 or more. Submission of a W-9 form is required prior to issuance of any rebate(s) totaling \$600 or more. Download the W-9 form [HERE](#).
