- 1. All bills are subject to the reimbursement fee set forth on Schedule No. UF.
- 2. Residential customers are defined as all single family customers with one dwelling unit that are individually metered.
- 3. Pursuant to Decision 19-05-044 and Advice Letter No. 1842-W, a surcharge of \$0.062 per Ccf will be applied to all metered customers' bills excluding customers that are receiving the CAP credit. This surcharge will offset the CAP credits and CAP administrative program costs recorded in the CAP Balancing Account.
- 4. Beginning July 1, 2021, as required by Section 792.5 of the Public Utilities Code, an increase in purchased power of \$0.0126/kWh and an increase in purchased water of \$0.0830/Ccf, an increase in Pump tax of \$0.02563/Ccf relative to the Purchased Power, Purchased Water and pump tax cost adopted by Decision No. 19-05-044 and an associated revenue increase of 1.18%, are being tracked in a reserve account.
