GSWC Residential Programs

Toilet Rebates

High-Efficiency Toilet rebates (HET) rebates are no longer available from GSWC for toilets that flush 1.28 gallons per flush. These toilets are now part of state code and are widely available. GSWC is encouraging customers to install Premium High-Efficiency Toilets (PHET) that are 20% more efficient than current HETs. All approved qualifying models have been tested and certified through the EPA Water Sense program.

Premium High Efficiency Toilet (PHET) Rebate

- Up to \$80.00 each limited to the cost of the toilet (installation not included)
- New toilet must flush 1.06 gallons per flush or less
- Must be replacing a toilet flushing 1.6 gallons per flush or more
- New toilet must be on the approved EPA WaterSense list found [HERE](#)
- Limit 2 per household

High Efficiency Clothes Washer (HECW) Rebate

- Up to \$80.00 for qualifying models on the list found [HERE](#)

Weather-Based Irrigation Controllers (Smart Controllers) Rebate

- Up to \$80 for approved models found [HERE](#)

Efficient Sprinkler Nozzle Rebate

- Up to \$4 per nozzle with a minimum purchase of 15

Premium High Efficiency Toilets (gravity and flush valve types)

- Up to \$80 for qualifying tank type models found [HERE](#)
- Qualifying flush valve models found [HERE](#)
- Replacing valves only does not qualify. Must replace toilet and valve



High Efficiency Urinals (low and zero water use)

- Up to \$200 for qualifying models found [HERE](#)

Weather-Based (Smart) Irrigation Controllers

- Up to \$80 for sites less than 1 acre
- Up to \$25 per valve for sites more than one acre

Efficient nozzles and rotors

- Up to \$4 per nozzle with a minimum purchase of 15

W-9 Tax Form Requirement

Federal IRS tax law requires water rebate program participants that receive \$600 or more in rebates in a calendar year to report that gain on their tax form. GSWC may issue a 1099 form on any rebate(s) totaling \$600 or more. Submission of a W-9 form is required prior to issuance of any rebate(s) totaling \$600 or more. Download the W-9 form [HERE](#).
