- 8. As authorized by the California Public Utilities Commission, an amount of \$0.045 per Ccf based on an 18-month amortization period, is to be added to the Quantity Rate, beginning on May 1, 2025 as indicated in Advice Letter 1958-W. The surcharge may be recalibrated annually, if necessary. This surcharge will recover the under collection in the WRAM/MCBA Balancing Account.
