SPECIAL CONDITIONS

1. All bills are subject to the reimbursement fee set forth on Schedule No. UF.
2. Pursuant to Decision No. 23-06-024 a surcharge of \$0.107 per Ccf will be applied to all metered customer bills excluding customers that are receiving the CAP credit. This surcharge will offset the CAP credits and CAP administrative program costs recorded in the CAP Balancing Account. (I)
3. As authorized by the California Public Utilities Commission, each customer served under this tariff schedule will receive a monthly sur-credit for a 3-month period, in the amount listed below, on the effective date of Advice Letter 1898-W, which is July 31, 2023. This refund includes the over collection of the WRAM&MCBA Balancing Account. (D)

7. As authorized by the California Public Utilities Commission in D.23-06-024, an amount of \$0.035 per Ccf is to be added to the quantity rate for a period of 12-months, beginning on the effective date of Advice Letter No. 1899-W. The surcharge will amortize the cumulative balance recorded in the Public Safety Power Shut-Off Memorandum Account as of September 30, 2020.

8. As authorized by the California Public Utilities Commission in D.23-06-024, an amount of \$0.008 per Ccf is to be added to the quantity rate for a period of 12-months, beginning on the effective date of Advice Letter No. 1899-W. The surcharge will amortize the cumulative balance recorded in the General Ratemaking Area Balancing Account as of September 30, 2020.
